<p>I declare the above to be correct and during the term of my membership I will abide by all the CBYC Bylaws and Rules. I also acknowledge that I may be subject to discipline if any of my family members or guests fail to abide by CBYC's Bylaws and Rules.</p> <p>I further agree that I will keep the above liability insurance policy or equivalent in force while my boat is docked or stored in the club.</p> <p>CBYC permits active senior members to store their boats on lands or waters leased by the club at the risk of the boat owner. I recognize that the club does not assume the care, custody or control of any member's boat, cradle or other equipment.</p> <p>I agree that any member of the Board of Directors of CBYC may take whatever step that he/she in their sole discretion deems necessary, or to direct any other person to take such step, to undertake any emergency action, work or other service to my Boat or to move or remove my Boat to safeguard CBYC's property or the health or safety of persons on or about CBYC's property and the costs of such emergency action, work or other service shall be undertaken and contracted on my behalf and I agree to immediately pay any bill, account or other charge. I acknowledge that no member of the Board of Directors of CBYC has any obligation to undertake any emergency action and that my boats seaworthiness and safe operation is my sole responsibility.</p> <p>I understand that while CBYC provides various services (eg: electricity, water, garbage disposal, etc.) and other forms of assistance to members, the club is not responsible in any manner whatsoever for any interruptions, breakdowns, suspensions or termination of any service or form of assistance to members no matter what the cause.</p> <p>I also recognize and accept that CBYC is a self-help club and that the work is done and services are provided by members who are commonly not professionals in that type of service.</p> <p>I agree that CBYC shall have a lien against my Boat and cradle for unpaid amounts outstanding including any membership fees or charges or any other amount which I owe pursuant to CBYC's Bylaws and Rules or this Membership Agreement pursuant to the Repair and Storage Liens Act, RSO 1990, c. R-25 and that CBYC may register the lien or a security interest against my Boat and cradle pursuant to the provisions of the Personal Property Security Act, RSO 1990, c P.10.</p>
